Each team to play two fixtures, with the group positions decided on points, then net run rate.

The **SIX GROUP WINNERS** and the **BEST TWO RUNNERS-UP** to qualify for the quarter-finals, which will be arranged as locally as possible, provided that the two runners-up will play away and no-one will meet a team from their own group.

#### Fixtures

The dates given are **final** dates and **MATCHES MUST BE PLAYED ON THESE DATES OR ANY EARLIER DATE** agreed by the competing teams. Matches may be rearranged for reasons of weather / ground conditions only. In the event of no play being possible on the listed final date, a match may be rearranged to take place a maximum of 10 days later (this to ensure that 2 Sundays are available).

PLEASE ARRANGE YOUR FIXTURES AS EARLY AS POSSIBLE – BOTH CLUBS HAVE EQUAL RESPONSIBILITY FOR CONTACTING EACH OTHER!

The first named club shall play at home. Matches must be played on the set dates or earlier by mutual agreement. Any re-arranged dates MUST be notified to the Competition Administrator immediately.

**Result Reporting** - Home clubs MUST input a play-cricket summary result within 24 hours of the match being played. No phone calls required unless the play cricket requirement cannot be fulfilled for some reason at the time. The away Club is then to confirm the result online at their Club's Play cricket website within 48 hours of the match being played in order to verify the result and points input relating to the match. If a full scorecard is not uploaded then a summary of the best performance (20 runs or more and 2 wickets or more) MUST be included in the highlights section.

**Postponed Matches** – DO NOT enter a result on Play-Cricket (e.g. Abandoned or Cancelled) as this effectively ends the match online. Simply type in the new rearranged fixture date ONLY and leave the rest blank. Additionally email the Competition Administrator with notification of the postponement.

**17.6.4 Scoring of points** In group matches, 5 points will be awarded for a win, 3 points for a tie, 2 points for an abandonment and 1 point for a loss. No points will be awarded for games not played, unless they are conceded or awarded as a walkover by the Competitions Committee.

**17.6.4.1** In the event of two teams being equal on points, the higher position shall be awarded to the team with the higher net run rate (based on runs per over in all completed matches).

$$\text{Net Run Rate} = (\text{Total Runs Scored} \div \text{Total Overs Faced}) - (\text{Total Runs Conceded} \div \text{Total Overs Bowled})$$
